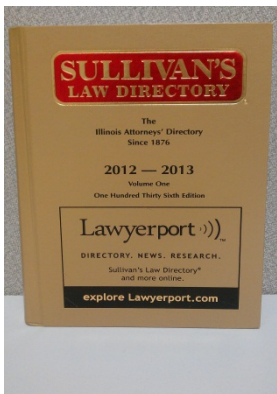

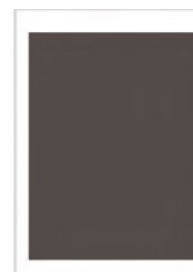
You MUST send all fonts and high res versions of the graphics used.

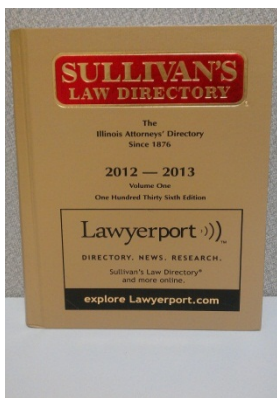
